**NOTICE OF RE-FILING AMENDED COMPLAINT NOT UNDER SEAL**

Plaintiff Federal Home Loan Mortgage Corporation (“Freddie Mac”) hereby gives notice of re-filing its Amended Complaint publicly and not under seal.

The Amended Complaint was filed on February 20, 2015 under seal (DE 42), accompanied by a motion to seal (DE 43). On March 6, 2015, the Court entered an order denying the motion to seal (DE 44). Following receipt of that order on March 6, Freddie Mac immediately conferred with counsel for the defendant, who requested that Freddie Mac not re-file the Amended Complaint until after counsel for Deloitte and Freddie Mac had further conferred today, Monday, March 9. The defendant agreed on March 6, however, that the re-filed Amended Complaint would be deemed filed as of February 20, 2015, nunc pro tunc. Today (March 9, 2015) defendant’s counsel advised Freddie Mac’s counsel that, in light of the Court’s order denying the application to file it under seal, Deloitte does not oppose the inclusion of its confidential information in the public filing of the Amended Complaint that was originally submitted under seal on February 20. Accordingly, Freddie Mac re-files the Amended Complaint dated February 20, 2015 not under seal.
